The above extension of provisional affiliation is sanctioned, subject to fulfillment of the following conditions /deficiencies pointed out by the University Inspection Committee TSCHE and general rules of affiliation.

1. The College has to appoint (04) Lecturer through a duly constituted Selection Committee as per OU norms.
2. The College has to purchase books worth Rs.50,000/- and Hotel Management Journals to be subscribed.
3. The College has to strengthen BTK, QTK, ATK Labs.
4. The College to be installed Chimneys in the kitchen.
5. The College has to purchase (10) Computers, with latest configurations.
6. The College has to enhance Library Space.
7. The College has to maintain Teaching Dairies and Students Attendance Registers properly.
8. The College has to prepare annual report every year.
9. The College has to conduct Governing Body Meetings at least thrice in a year by associating University representative.
10. The College has to pay salaries through Bank/Account Payee Cheques only.
11. The College has to depute the faculty for Refresher Courses / Orientation Programmes/Faculty Development Programmes conducted by Osmania University /Other Institutions.
